PROCESS DOCUMENT

Introduction:

Expression of Interest (“EoI”) is invited from the Prospective Bidders in the matter of Eastern Sugar & Industries Limited, the Corporate Debtor undergoing CIRP. The Corporate Insolvency Resolution Process of Eastern Sugar & Industries Limited has commenced with effect from 11th February, 2022, vide an order by the National Company Law Tribunal (NCLT), Kolkata Bench. The Resolution Professional, Mr. Anup Kumar Singh, was appointed in the matter on 10th April, 2022.

Eastern Sugar & Industries Ltd. with CIN L15421BR1964PLC006630 is a Public Listed Indian Non-Government Company, registered at Patna (Bihar), with a paid up capital of INR 33.90 Crores. The registered office of the Corporate Debtor is situated at PO. Hanuman Sugar Mills, Motihari, P.S.-Motihari East Champaran, Bihar - 845401 and the corporate office of the Corporate Debtor is situated at Chandra Kunj, 4th floor, 3, Pretoria Street, Kolkata - 700071. The Equity Shares of the Corporate Debtor are listed with the Bombay Stock Exchange and National Stock Exchange. However, trading in Shares of the Company in both the Exchanges is suspended due to Penal Reasons.

The Corporate Debtor was established in the year 1964 under the name and style of Eastern Polymers Corporation Ltd, which was subsequently changed to its present name on 14-12-1993. The Registered office of the Corporate Debtor was transferred from the State of West Bengal to the State of Bihar on dated 25-07-1995. As on date, six (6) Directors are associated with the company namely Shirish Goswami, Bijan Aditya, Ankita Srivastava, Chandan Sharma, Khushbu Sharma and Subir Kumar Dey. There are no directors in this company who are 'Disqualified by ROC u/s 164(2).

On 27-04-2022, the first Form G inviting expression of interest was published in two locations, first being the location of the Registered Office of the Corporate Debtor in two newspapers i.e. Morning India (English) and Sanmarg (Hindi), Patna Edition and second being the location of the Corporate office of the Corporate Debtor in two newspapers, Business Standard (English) and Ekdin (Bengali), Kolkata Edition. Thereafter, extension notices dated 13-05-2022 and 11-06-2022 were published in the above mentioned newspapers extending the last date for the submission of expression of interest.

About the business of the Company:

As per Memorandum of Association of the Corporate Debtor and other Industry classification records, the main line of business is in the manufacturing and refining of molasses, sugar, sugar products and sugar by products. The company was initially incorporated with the object to carry on the business as exporters, manufacturers, importers, buyers and sellers of and dealers in all Chemicals (including without prejudice to the said generality and in particular Soda Ash, Caustic Soda, Sulphur, Sulphuric Acid, Sodium sulphate, Calcium sulphate, Super phosphate, Ammonium Chloride, DI-Calcium Phosphate, Alcohol, Chlorine, Chlorine products, both organic and inorganic such as polyvinyl Chloride carbon tetrachloride, trichloroethylene, perchloroethylene, Ethylene dichloride, carbon disulphide, Barium chloride, Aluminium trichloride, Iltanium tetrachloride etc.) alkalis, acids, cordials,

drugs, tannins, essences and pharmaceutical, photographic, sizing, medical, chemical, industrial and other preparations and articles of any nature and kinds whatsoever. The Company has filed its Annual Returns and/or Financial Statements upto 31-03-2021 i.e. FY 2020-2021 and the AGM for FY 20-21 was held on 29/09/2021.

Transaction Process:

The transaction process for the Corporate Debtor as aforesaid shall be completed in Two Stages, brief of which is discussed as under:

Stage I:

- Submission of Resolution Plan by RAs along with requisite documents and EMD/Financial Bank Guarantee in terms of the RFRP for the Corporate Debtor.

Provided that the person shall be eligible to submit a Resolution Plan if such person makes payment of all overdue amounts with interest thereon and charges relating to non-performing asset accounts before submission of Resolution Plan:

Provided further that nothing in this clause shall apply to a Resolution Applicant where such applicant is a financial entity and is not a related party to the corporate debtor.

Explanation I- For the purposes of this proviso, the expression "related party" shall not include a financial entity, regulated by a financial sector regulator, if it is a financial creditor of the corporate debtor and is a related party of the corporate debtor solely on account of conversion or substitution of debt into equity shares or instruments convertible into equity shares, prior to the insolvency commencement date.

Explanation II. – For the purposes of this clause, where a Resolution Applicant has an account, or an account of a corporate debtor under the management or control of such person or of whom such person is a promoter, classified as non-performing asset and such account was acquired pursuant to a prior Resolution Plan approved under this Code, then, the provisions of this clause shall not apply to such Resolution Applicant for a period of three years from the date of approval of such Resolution Plan by the Adjudicating Authority under this Code;

- (d) has been convicted for any offence punishable with imprisonment –
 - (i) for two years or more under any Act specified under the Twelfth Schedule; or
 - (ii) for seven years or more under any law for the time being in force:

Provided that this clause shall not apply to a person after the expiry of a period of two years from the date of his release from imprisonment:

Provided that this clause shall not apply in relation to a connected person referred to in clause (iii) of *Explanation I*

- (f) is prohibited by the Securities and Exchange Board of India from trading in securities or accessing the securities markets;
- (g) has been a promoter or in the management or control of a corporate debtor in which a preferential transaction, undervalued transaction, extortionate credit transaction or fraudulent transaction has taken place and in respect of which an order has been made by the Adjudicating Authority under this Code:

Provided that this clause shall not apply if a preferential transaction, undervalued transaction, extortionate credit transaction or fraudulent transaction has taken place prior to the acquisition of the corporate debtor by the resolution applicant pursuant to a resolution plan approved under this Code or pursuant to a scheme or plan approved by a financial sector regulator or a court, and such resolution applicant has not otherwise contributed to the preferential transaction, undervalued transaction, extortionate credit transaction or fraudulent transaction;]

- (h) has executed a guarantee in favour of a creditor in respect of a corporate debtor against which an application for Insolvency Resolution made by such creditor has been admitted under this Code and such guarantee has been invoked by the creditor and remains unpaid in full or part;
- (i) is subject to any disability, corresponding to clauses (a) to (h), under any law in a jurisdiction outside India; or
- (j) has a connected person not eligible under clauses (a) to (i).

Explanation [I] – For the purposes of this clause, the expression "connected person" means –

- i. any person who is the promoter or in the management or control of the resolution applicant; or
- ii. any person who shall be the promoter or in management or control of the business of the corporate debtor during the implementation of the resolution plan; or
- iii. the holding company, subsidiary company, associate company or related party of a person referred to in clauses (i) and (ii):

Provided that nothing in clause (iii) of Explanation I shall apply to a Resolution Applicant where such applicant is a financial entity and is not a related party of the corporate debtor:

- d) an Asset Reconstruction Company register with the Reserve Bank of India under Section 3 of the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 (54 of 2002);
- e) an Alternate Investment Fund registered with Securities and Exchange Board of India;
- f) such categories of persons as may be notified by the Central Government.
